#### **Healthy Transitions for Adolescent Girls**

Empire West

"Healthy Transitions for Adolescent Girls" will discuss ways to engage the 1.5 billion people between the ages of 10 and 25 (85 percent of whom live in developing countries) to make a difference. The panel will acknowledge critical challenges faced by adolescent girls: In many countries, one in seven young women marries before age 15; one in three faces a five-times higher risk of death as a result of giving birth before age 20; and over half lack essential nutrients. Girls represent two-thirds of people under age 25 living with HIV/AIDS. #### **Expanding the Global Health Workforce**

"Expanding the Global Health Workforce" will investigate a challenge to global health that has little to do with microorganisms: a world-wide shortage of 4 million health workers. #### Ensuring a Healthy Start: Maternal and Child Nutrition

New York East

"Ensuring a Healthy Start: Maternal and Child Nutrition" will stress the elemental impact that maternal health has on the health of children. Under-nutrition accounts for one in three child deaths, or 3.5 million annually. Some children do not get enough food and protein, while others suffer from vitamin and mineral deficiencies. Infants and young children under the age of two are particularly vulnerable. Under-nutrition during this time contributes to high child mortality rates and has long-lasting, disabling impacts on health and intellectual development – including a greater risk of chronic disease in adulthood. The current food crisis is making things worse, but it also provides an opportunity for the world to take steps to improve both the quantity and quality of food. This panel will discuss interventions that can save lives, such as early and exclusive breastfeeding, micronutrient fortification of staple foods, and the development of nutrient-rich foods for infants and young children.

#### Safe Drinking Water and Sanitation

Empire West

"Safe Drinking Water and Sanitation" will search for one of the most ancient sources of health known to humankind: clean water. Currently, a billion people worldwide lack access to safe drinking water and more than 2.6 billion people lack access to basic sanitation. Water-related diseases kill 3.5 million people every year and rank as the second-leading cause of death among children under five. Although the technology exists and the social payoff is high (\$8 for every dollar invested) — the global community has not solved this problem. This panel will explore sustainable, community-led solutions to the global water and sanitation crisis. In particular, the panel will focus on decentralized solutions, such as "point of use" technologies for household use, or community-based "micro-utilities" that can deliver safe drinking water as a service with modest capital expenditures.
